

<b>SWS-42</b>	<b>Vessel Physical Damage Sworn Written Statement for Ownership of Vessel</b>

The Settlement Agreement requires Vessel Physical Damages claimants to submit proof of both registration and title to the damaged vessel at the time of the damage during the period from April 20, 2010, and December 31, 2011. A claimant who has submitted proof of registration or title but not both may use this SWS-42 in place of the missing title or registration. In addition, a claimant who does not own 100% of the vessel may use this SWS-42 to establish the claimant's percentage ownership interest. The claimant must sign this Form. A lawyer cannot sign on the claimant's behalf.
